Introduction

A safe and secure campus is a high priority at Roanoke College. Community awareness and cooperation, along with the guidance and support of a well-trained, professional Campus Safety Staff, contributes to a positive learning environment. Please read this report, which describes important information about Campus Safety and outlines your responsibilities as a member, or potential member, of our community. Roanoke College is located in Salem, VA and the community is made up of about 1,778 students and approximately 620 employees.

Preparation of this Report

Compilation and distribution of this report is mandated under the Jeanne Clery Disclosure of Campus Safety & Security Policy and Campus Crime Statistics Act (Clery Act). This includes information which describes important information about Campus Safety and outlines your responsibilities as a member or potential member, of our community.

The Annual Security and Fire Reports contains crime and fire statistics for the three previous calendar years and information on safety and security. The crime statistics contained in this report include statistics for Clery Act Crimes identified by or reported to the Office of Campus Safety by designated Campus Security Authorities (including, for example, athletic coaches, deans, advisors and resident advisors). Crime statistics also include information from local law enforcement on Clery Act crimes reported within the Clery Act geographical locations.

This report also contains statistics for weapons, drug and liquor law violations that resulted in arrest or referral for disciplinary action. This information is reported to the Office of Campus Safety by the Dean of Students Office.

The Office of Campus Safety prepares and distributes a Notice of Availability of the Annual Safety and Security report & the Annual Fire Safety Report by October 1st of each year to every member of the College community. Anyone, including prospective students and employees, may obtain a paper copy of these reports by contacting the Office of Campus Safety (540-375-2310, 9 N. Office of Campus Safety (540-375-2310)

The Office of Campus Safety, located at 9 North College Avenue, provides 24-hour-a-day security, law enforcement and safety services to the campus community. Officers have two-way radio communications and conduct foot, bicycle and vehicle patrols of the campus grounds, academic and administrative buildings and residence halls. Certain areas of the campus are monitored by the use of internet protocol (IP) cameras. Officers are appointed by the Circuit

Court as Armed Special Conservators of the Peace with authority to make arrests on Roanoke College property. The College works closely with the City of Salem Police Department, which is located approximately four blocks from campus, and maintains two-way radio communications with the Salem Emergency Services Dispatcher. Campus Safety Officers receive law enforcement training through the Cardinal Criminal Justice Regional Academy and comply with the Virginia Department of Criminal Justice Services training standards. Campus Safety has engaged in Mutual-Aid Agreements with the Salem Police Department and the Virginia State Police to assist or lead in providing patrol and/or investigative services as needed for any situation, including sexual assault cases. Campus Safety also works closely with all Local, State and Federal law enforcement agencies. Criminal offences reported to Campus Safety are reported to the Salem Police via written report. Weekly communications between the command staff of both departments keep the College aware of any offenses or arrests involving members of the College community. Campus Safety Officers are armed with firearms and the department is comprised of one Director and eight full-time officers.

The Roanoke College campus is located in the City of Salem, VA, and encompasses approximately 130 acres and the core of the campus is located between East Main Street and Hawthorne Road, from Thompson Memorial Drive and just south of Market Street. The nearby Elizabeth Campus is located between Lynchburg Turnpike and Idaho Street.

Security Awareness & Prevention Program

- Roanoke College offers security awareness and prevention programs for students and employees.
- The Office of Campus Safety provides safety and crime prevention training to all Residence Life & Housing, Student Activities and Colket Center student and professional staff annually in August.
- All First-Year students are required to attend safety and crime prevention training, conducted by the Office of Campus Safety, each semester in August and January. This training includes but is not limited to, tips on personal safety and property protection, alcohol and drug awareness, and information on sexual assault, dating and domestic violence, and stalking.
- All First-Year students are required to attend "What to do in an Emergency" in August and January each year. This training includes information on what to do during crimes in progress, fires, medical situations, weather events, and active shooter situations.
- The Office of Campus Safety provides Situational Awareness Training for faculty, staff, and students multiple times per academic year.
- The Office of Campus Safety offers self-defense and Rape Aggressions Defense (R.A.D.) training to the campus community each semester.
- The Campus Safety Lieutenant for Neighborhood Outreach and Education attends residence hall meetings in each Residence Life & housing neighborhood and provides safety and crime prevention information to students on a monthly basis.

Safety & Security Guidelines

- We encourage all students, faculty, staff and visitors to take an active role in their own safety and security while on campus. By following these guidelines, you can help maintain a safe environment for yourself and others at the College.
- Walk in well-lit and well-traveled areas after dark. Walk with a friend or call Campus Safety for an escort.
- We encourage all students, faculty, staff and visitors to take an active role in their own safety and security while on campus. By following these guidelines, you can help maintain a safe environment for yourself and others at the College.

- Immediately report all suspicious persons, vehicles or activities to the office of Campus Safety.
- Immediately report all crimes, security problems or hazardous conditions to the Office of Campus Safety.
- Keep yourself informed. Check e-mail, campus bulletin boards, Brackety-Ack (the student newspaper) and your campus mail for "Campus Safety Notices."
- All faculty, staff and students are automatically enrolled in MAROON ALERTS (text message alerts).
- Keep residence hall room doors locked at all times and do not loan keys to unauthorized persons or allow unauthorized persons into the residence halls.
- Keep your Maroon Card, phone and room keys with you at all times.
- Use the peephole in your door to screen visitors.
- Do not prop open any locked exterior doors or leave ground-floor windows open.
- Never study alone in an isolated area of a campus building.
- Lock your car and secure valuables when using campus parking facilities.
- Use bicycle racks located on campus and lock your bicycle with a high-quality lock.
- Become familiar with the red phones located inside several campus buildings, the Blue Emergency Telephones located in certain parking lots, and the Courtesy telephone locations.
- Become familiar with Residence Life and Housing policies at https://tinyurl.com/Res_Life-Policies and the Student Conduct policies at https://www.roanoke.edu/studentconduct.
- Know the emergency exits and locations of fire alarm pull stations and extinguishers in your building.
- Lock offices when you are not present.
- Do not respond to unsolicited emails or messages regarding employment from people you do not know.

- Never give out credit card or bank information to unknown callers or requests via email.
- Always use caution when using a taxi, Uber or Lyft for transportation.

Ridesharing Safety Tips

- Request your ride while indoors to minimize the amount of time outside.
- Check your ride every time to make sure you are getting into the right vehicle.
- Have the driver confirm your name before entering the vehicle.
- Sit in the back seat whenever possible as this helps ensure you can safely exit.
- Always wear your seatbelt.
- Share your trip details with family or friends.
- Protect your personal information.
- Follow your intuition and trust your instincts. If you feel you're in an urgent situation, you can call 911 by using the emergency button on the app or call 911 using your cell phone.
- Be respectful
- Give honest feedback about your trip.

Emergency & Evacuation Procedures

Fire

- Pull fire alarm and evacuate building using the closest exit;
- Call Campus Safety at 540-375-2310 and 911;
- Help others evacuate;
- Do not use elevators;
- Do not return to the building until an all-clear is given by Campus Safety or the Fire Department.

Medical Emergency

- Contact Campus Safety at 540-375-2310;
- Give name, location, description of emergency and the number of people injured;
- Stay on the phone;
- Contact 911 if injury / illness is life threatening.

Severe Weather

- Seek safe shelter indoors;
- Follow Maroon Alert instructions;
- Check e-mail, local media and Roanoke College website for updates.

Tornado

- Shelter in place away from windows and in the lowest area of the building;
- Follow instructions from Maroon Alerts and local media.

Active Shooter

Run, Hide, Fight

Run

- Have an escape route & plan in mind;
- Leave your belongings behind;
- Keep your hands visible;
- Call 911 as soon as you are safe.

Hide

- Hide in an area out of the shooter's view;
- Block entry to your hiding place and lock doors if possible;
- Turn out the lights;
- Close blinds and windows;
- Silence smart phones;
- Turn off radios, TVs & computer monitors;
- Keep out of sight and take cover under the desk or behind file cabinets, large furniture or other solid structure;
- Keep fellow occupants calm, quiet and out of sight;
- If you can't escape or hide, fight.

Fight

- As a last resort and only when your life is in imminent danger;
- Attempt to incapacitate the active shooter;
- Act with physical aggression and throw items at the active shooter, kick, scratch, bite, whatever it takes to stay alive;
- Use whatever is near you fire extinguishers, chairs, tables, keys, anything that could blind or disable the attacker.

Law Enforcement Arrival

- Remain calm and follow the officer's instructions;
- Immediately raise your hands and spread your fingers;
- Keep hands visible at all times;
- Avoid making quick movements toward officers;
- Avoid pointing, screaming or yelling;
- Do not stop to ask officers for help or directions;
- Follow all of the officer's instructions immediately;
- Proceed in the direction from which the officers are entering the building.

Testing Emergency Response & Evacuation Procedures

The Roanoke College emergency texting (Maroon Alerts) system is tested once per semester to ensure all students, faculty and staff are familiar with the emergency alerts and what their individual roles are during an actual situation. These tests are not announced.

Fire and evacuation drills are unannounced and coordinated by the Office of Residence Life & Housing and the Office of Campus Safety, at least once each semester in each residence hall and academic building. Designated long-term evacuation sites are not announced as those decisions are impacted by situational circumstances. The purpose of evacuation drills is to prepared the community for an organized evacuation in case of an emergency.

Each drill or test is documented with the description of the event, including the date and time and whether or not the event was announced. A communication to the community will be made highlighting emergency procedures and evacuations in conjunction with at least one test per calendar year.

Emergency Notifications & Timely Warnings

Roanoke College will issue a Timely Warning when a crime is reported to or brought to the attention of the office of Campus Safety or other Campus Safety authorities and when that crime represents a serious or ongoing threat to the safety of members of the Roanoke College community.

Information for timely warnings may also come from law enforcement authorities. Every attempt will be made to issue the warning as soon as possible after the incident is reported, however, the release is subject to the availability of accurate facts concerning the incident.

Timely Warning Notices are sent using campus-wide e-mail for incidents or situations that do not pose an immediate threat, but which require a timely notice in compliance with the Clery Act. Notices may also be made by campus mail, announcements posted on bulletin boards, social media and specially called residence hall meetings. The College Emergency Alert System is tested annually. The Campus Safety Office also sends out Campus Safety Notices.

Maroon Alerts is a multi-modal emergency notification system that sends notifications via text message to cellular phones and other electronic devices / media. Notifications are sent upon confirmation of a significant emergency or dangerous situation involving an immediate threat to the health or safety of the College community. Weather closings and delays are also sent through the Maroon Alert system. Students, faculty and staff are automatically enrolled in the program and must opt out if they choose not to receive the alerts. The Maroon Alerts emergency information system is tested once per semester and this test is unannounced. Information regarding emergency response is distributed via email after the tests. The Campus Safety Office, Dean of Students Office and the Office of Marketing & Communications can activate the Maroon Alert System.

Weapons Policy

Roanoke College is committed to providing a safe and secure learning and working environment for students, faculty, staff and visitors in all campus buildings and on College grounds. The possession, storage and use of all firearms, weapons, explosives or other dangerous articles are prohibited on all properties owned, leased or otherwise controlled by Roanoke College. Items resembling firearms, explosives or other weapons are likewise prohibited on College properties. Firearms and other weapons carried by duly authorized law enforcement officers or college security personnel are exempt from this policy.

Emergency & Courtesy Telephones on Campus

Blue Light Emergency Phones are located at the following locations and provide a direct dial to the Office of Campus Safety as well as 911:

- One at the north end of the Hawthorne Road parking lot (P-21)
- One at the south end of the Hawthorne Road parking lot (P-21)
- One at the west side of Maxey Hall
- One on the east side of Maxey Hall, along the Athletic Quad sidewalk
- One in the Lower Olin parking lot (P-11)
- One in the parking lot at the end of Red Lane (P-22)
- One at the Elizabeth Campus Tennis facility (P-26)
- One on the Elizabeth Campus quad
- One in the Cregger parking lot (P-9)

Red Emergency Telephones are located throughout campus, inside the following buildings and provide direct contact with the Campus Safety office. These phones are for emergencies or to request a campus escort:

- Alumni Gym
- Colket Center
- Fintel Library
- Olin Hall

How to Get Help, Report an Emergency, Crime or Missing Person

All emergencies, criminal acts, missing persons or questionable behavior should be reported immediately to the Office of Campus Safety, either in person or by telephone. Campus Safety can be reached directly by dialing 540-375-2310 or by dialing 540-375-2500 or "0" on a phone connected to the campus telephone network outside of regular business hours (8am – 4:30pm, Monday – Friday), or by using a red or blue Emergency Telephone located on campus. The Salem City Police, Fire and Rescue can be reached by dialing 911.

Campus Security Authority

A Campus Security Authority is an individual who is an official of the institution that has significant responsibility for student and campus activities. Examples may include, but are not limited to:

- Director of Residence Life & Housing (540-375-2308)
- Dean of Students (540-375-2592)
- Associate Dean of Students (540-375-2592)

- Title IX Coordinator (Vice President, Dr. Teresa Ramey, 540-444-4535)
- Deputy Title IX Coordinator (Senior Director, Michele Vineyard, 540-375-2262)*
- Deputy Title IX Coordinator (Assistant Dean, Amy Perkins, 540-375-2597)*

Call Campus Safety (540-375-2310) or 911 if the incident is an emergency.

Under the Clery Act, a crime is reported when a victim, witness, other third party or even the offender brings it to the attention of a Campus Safety Authority or local law enforcement personnel. It does not matter whether or not the individual(s) involved in the crime or reporting the crime are associated with the institution. If a Campus Safety Authority receives the crime information and believes it was provided in good faith, they will document it as a crime and provide the report to the Office of Campus Safety. In "good faith" means there is a reasonable basis for believing the information is not hearsay or rumor. Campus Safety Authorities are not responsible for investigating crimes. All investigations and crime classifications are the responsibility of sworn law enforcement personnel.

There are two classifications of individuals who, although they have significant responsibilities for students and campus activities, are not considered Campus Safety Authorities under Clery: Pastoral counselors and professional counselors. Although pastoral counselors and professional

counselors do not have to report crimes brought to their attention while serving in an official capacity, they are encouraged to inform their clients of the procedures to report crimes on a voluntary and confidential basis for inclusion in the annual crime statistics.

Silent Witness Program

Community members wishing to remain anonymous and report information about criminal acts or suspicious activities on campus can do so by using the Silent Witness Form found at https://webforms.roanoke.edu/silent-witness (login required) or by using the link found on the Campus Safety website, https://www.roanoke.edu/safety. An individual using the program supplies information on an electronic form. That confidential information is then routed via e-mail directly to the Campus Safety Office for follow-up investigation or appropriate action. This information may be included in the crime statistics.

Students in Emotional Distress / Health & Counseling Center

Students who may be experiencing emotional distress or who may know someone experiencing it can get help from the Student Health & Counseling Center located at 310 N. Market Street (Bast Center), 540-375-2286. Hours of operation are Monday – Friday, 8:30 am – 5 pm. Outside of business hours, the College provides access to TimelyCare 24/7 Telehealth, an ondemand resource where students are able to talk with a mental health professional at any time. In situations where immediate help is needed, please contact the Office of Campus Safety at 540-375-2310 and an officer will respond to assist the person in contacting the on-call counselors.

Roanoke College Care Team

The Care Team is comprised of College officials who meet regularly to review students of concern. Information concerning students who may be in distress, in need of medical attention, who may pose a threat to self or others or who are experiencing difficulty with the transition to college should be reported to a member of the Care Team. Additionally, if you have concerns about a student's academic performance, please report those concerns as there may be underlying issues that Care Team can address. This centralized team will investigate the concerns and provide timely and appropriate intervention.

If you are concerned about a student's immediate health, safety or welfare, please call the Campus Safety Office at 540-375-2310. Campus Safety staff members can assist you with assessing the situation and determining if immediate action is necessary or if a referral to the Care Team may be more appropriate.

Missing Persons

This policy is established by Roanoke College in compliance with the *Higher Education Opportunity Act of 2008* and applies to residential students at the college. For the purposes of this policy, a student may be considered to be a *missing person* if the person's absence from campus is contrary to their usual pattern of behavior and unusual circumstances may have caused the absence. Such circumstances could include, but not be limited to, a report or suspicion that the person may be a victim of foul play, has expressed suicidal thoughts, is drug dependent, is in a life-threatening situation, has been with persons who may endanger the student's welfare or is overdue to return to campus and is unheard from after giving a specific return time to friends or family.

Designation of Emergency Contact Information

a. Students age 18 and above and emancipated minors

Students will be given an opportunity during the *annual registration process* to designate an individual to be contacted by the College no more than 24 hours after the time that the student is determined to be missing. The designation will remain in effect until changed or revoked by the student.

The contact information is confidential and only accessible to authorized campus officials. This information may not be disclosed except to law enforcement officials in furtherance of a missing persons investigation.

b. Students under the age of 18

If a student under the age of 18 is determined to be missing, the College is required to notify a custodial parent or guardian no more than 24 hours after the student is determined to be missing.

c. All residential students (both a and b above)

If a student is determined to be missing, the College will notify the appropriate law enforcement agency no later than 24 hours after the determination has been made, unless the local law enforcement agency was the one who determined the student missing.

Missing Student Procedure

a. Any individual on campus who has information that a residential student may be a missing person / has been missing for 24 hours must notify the Office of Campus Safety immediately. The Office of Campus Safety (540-375-2310) is located at 9 N. College Avenue. The following offices may also be contacted regarding a missing

student: The Office of Residence Life & Housing (540-375-2308) located at 105 N. Colorado Street and the Dean of Students Office (540-375-2592).

- b. The Office of Campus Safety will gather all essential information about the missing resident from the person reporting, from the student's acquaintances and from College personnel and official College information sources. Such information will include a physical description, cellular phone number, clothes last worn, where the student might be, who the student may be with, vehicle description, information about the physical and emotional well-being of the student, an up-to-date photograph, class schedule, when class was last attended, last use of Maroon card, etc.
- c. Appropriate campus staff, including the Area Director on Duty and Residence Life & Housing Staff, will be notified to aid in the search and location of the student. Contact with the student should be attempted using text messaging, cellular phone calls and e-mail.
- d. If search efforts are unsuccessful in locating the student in a reasonable amount of time, OR it is immediately apparent that the student is a missing person (e.g. witnessed abduction), OR it has been determined the student has been missing more than 24 hours, the Office of Campus Safety will contact the Salem Police Department or appropriate law enforcement agency, unless the local law enforcement agency determined the student missing, to report the student as a missing person. The Salem Police Department will take charge of the investigation with assistance from College officials.
- e. No later than 24 hours after determining that a residential student is missing, the Director of Campus Safety, or designee, will coordinate the notification of the emergency contact previously identified by the student (for students 18 and over) or the custodial parent / guardian (for students under the age of 18) and advise that the student is believed to be missing.
- f. The Office of the Registrar requires all students to complete the Annual Enrollment Profile. Students are to list an emergency contact person and provide additional information, including the relationship to the student, and phone numbers. This information is confidential and is only accessible to authorized campus officials and may not be disclosed, except to law enforcement personnel in the furtherance of a missing persons investigation.

Students may also change their emergency contact information at any time by accessing the Annual Enrollment Forms at https://selfservice.roanoke.edu/Student/Account/Login and choosing User Options from the menu on the left-hand side or in person at room 101 in the Administration Building.

Communications About Missing Students

In accordance with established College emergency guidelines procedures, the Director of Public Relations will be part of the College administrative response team and is the designated spokesperson to handle media inquiries concerning a missing student.

Escort / Ride Service

The Office of Campus Safety provides escort services to students, faculty, staff and guests who wish to be accompanied when walking across campus. This service is available 24 hours a day / 7 days a week and can be accessed by calling the Office of Campus Safety at 540-375-2310.

Building Security

Campus Buildings are patrolled on a regular basis by Campus Safety Officers. Administrative and Academic buildings are locked after business has concluded for each building. Residence Life & Housing staff have duty hours in residence halls and routinely check these buildings.

Doors to residence halls are locked 24 hours a day, 7 days a week. Residential students are provided with card access to their building and a room key for their individual room. Propping open a locked door is a serious violation of the Student Conduct Code and should be reported immediately.

Roanoke College has an automated work order procedure to ensure that repairs and maintenance related to safety and security are completed in a timely fashion. Repairs such as burned-out lights, missing window screens, or broken locks should be reported to a Residence Life or Campus Safety staff member. Work orders for repairs can also be submitted through a form on the Roanoke College website: https://v1-identity.dudesolutions.io/app/login/username. Plant Administration staff is on call for emergency repairs after normal business hours and can be reached by calling 540-375-2310.

Alcohol Policy

Roanoke College does not encourage the use of alcoholic beverages by students nor does it condone violation of applicable State laws or College policies. Students of legal age (21) may consume alcoholic beverages in the privacy of their rooms and at registered social events at which the College has approved alcohol. Individuals who consume alcoholic beverages are responsible for their own behavior. Regardless of a student's age, alcoholic beverages are not permitted in First-Year residence halls or in First-Year rooms of mixed class (first-, second-, third-year, etc.) residence halls.

Students violating College policies regarding alcohol are subject to campus disciplinary action with sanctions ranging from fines and community restitution to dismissal from the College. In

addition to disciplinary action, student violators may be criminally charged. See the Student Handbook for details.

College employees are expected to follow college alcohol policies consistent with State law. For details, please see "Policy Statement on Substance Abuse" in the Staff Handbook or "Policy Statement on Substance Abuse" in the Faculty Handbook. Employees violating College policies are subject to disciplinary action.

Drug Policy

Possession, use, manufacture and/or distribution of illegal drugs, drug paraphernalia containing drug residue and other controlled substances are violations of the Student Conduct Code. Any member of the campus community found violating this policy is subject to severe disciplinary action, including dismissal from the College. In addition, such individuals are subject to criminal prosecution. In these matters, the College fully cooperates with law enforcement officials, including the Salem Police, Virginia State Police and the U.S. Postal Inspector's Office. The names of students involved in illegal drug offenses are reported to the appropriate law enforcement agency. For details, see the Illegal Drug and Controlled Substance Policy in the Student Handbook. A Policy Statement on Substance Abuse is also available in the Faculty and Staff Handbooks.

Alcohol & Drug Abuse Education Program

- All First-Year students are required to complete AlcoholEDU, a comprehensive online
 education program designed to provide students with the tools to make informed
 decisions about alcohol, link their choices about drinking to academic and personal
 success, and help cope with the drinking behaviors of peers. This online program is
 completed before student arrival in August.
- Student Health & Counseling conducts Community Meetings for all First-Year students
 during New Student Orientation. This training is designed to raise awareness of various
 College health topics, including mental health and the non-medical use of prescription
 drugs, illegal substances, recognizing signs of alcohol poisoning, alcohol harm reduction,
 alcohol polices and resources in Campus Recreations, Counseling Services, Student
 Activities and Campus Safety.
- Reality Check and Let's Be Blunt are evidence-based programs designed to engage students in meaningful discussions about alcohol and marijuana use. This educational programming is provided by Student Health & Counseling with support from Student Conduct. Referrals to these programs come from Student Conduct, connected to violations of alcohol and marijuana related violations.
- Screening and Brief Intervention (SBI) is an American Public Health Association programed designed to identify individuals with alcohol-use problems. The purpose is to

increase student awareness of alcohol use and its consequences, then motivate the student to either reduce risky drinking behavior or seek treatment, if needed.

• TIPS (Training for Intervention Procedures) is the global leader in education and training for the responsible service, sale and consumption of alcohol. Proven effective in third-party studies, TIPS is a skill-based program that is designed to prevent intoxication, underage consumption and drunk driving. The training is a 3-hour course that teaches bystander intervention, risk management and personal responsibility regarding alcohol. This training is conducted by Residence Life & Housing, Campus Safety and Student Health & Counseling, and is geared toward organizations responsible for hosting events involving alcohol.

Criminal Offense Log

In accordance with the provisions of the Clery Act, a Campus Crime & Fire Log is maintained by the Office of Campus Safety. Interested persons can access this information by contacting the Office of Campus Safety and requesting to view the Campus Crime & Fire Log during regular business hours. The Office of Campus Safety is located at 9 North College Avenue.

Campus Crime Statistics Geography

The statistical data reported for on-campus offenses and all discipline referrals are compiled from records maintained by the Campus Safety Office, the Student Life Office and the Salem Police Department. Data for public property offenses may be obtained from the Salem Police Department. The Clery Act defines the location categories used.

On-Campus – Any building or property owned or controlled by the institution within the same reasonably contiguous geographical area and used by the institution in direct support of, or in a manner related to, the institution's educational purposes, including residence halls.

Any building or property that is within or reasonably contiguous to paragraph (1) of this definition, that is owned by the institution but controlled by another person, is frequently used by students and supports the institutional purposes.

Residential, On-Campus Housing Facility – Any student Housing facility that is owned or controlled by the institution, or that is located on property that is owned or controlled by the institution, and is within the reasonably contiguous geographic area that makes up the campus, is considered an on-campus student housing facility.

Public Property – All public property such as streets, thoroughfares, sidewalks and parking facilities within the campus or immediately adjacent to the campus.

Non-Campus – Any building or property located off campus and owned or controlled by a student organization officially recognized by the College, or any building or property owned or

controlled by an institution that is used in direct support of, or in relation to, the institution's educational purposes, is frequently used by students, and is not within the same reasonably contiguous geographic area of the institution.

The criminal offenses are classified using the FBI's Uniform Crime Reporting System definitions. The reader should keep in mind that some crime victims may choose not to report offenses to campus or local law enforcement authorities and that violations listed may result in both arrest and disciplinary referral for the same offense. Other types of unacceptable conduct, such as theft and vandalism, occur on college campuses. All criminal activity is detrimental to the College community, and strong measures, including dismissal, are taken against offenders.

Campus Crime Definitions

- Murder and Non-Negligent Manslaughter the willful (non-negligent) killing of one human being by another.
- **Negligent Manslaughter** the killing of another person through gross negligence.
- A **Forcible Sex Offense** any sexual act directed against another person without consent of the victim, including instances where the victim is incapable of giving consent.
- **Rape** defined as penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.
- **Fondling** the touching of private body parts of another person for the purpose of sexual gratification, without consent of the victim, including instances where the victim is incapable of giving consent because of age or because of temporary or permanent mental incapacity.
- **Incest** defined as sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.
- **Statutory Rape** sexual intercourse with a person who is under the statutory age of consent.
- **Domestic Violence** a felony or misdemeanor crime of violence committed:
 - o By a current or former spouse or intimate partner of the victim;
 - o By a person with whom the victim shares a child in common;
 - By a person who is cohabitating with, or has cohabitated with, the victim as a spouse or intimate partner;

- By a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction in which the crime of violence has occurred:
- By any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction in which the crime of violence has occurred.
- **Dating Violence** violence committed by a person who has or has been in a relationship of a romantic or intimate nature with the victim. The existence of such a relationship shall be determined based on a consideration of the following factors:
 - Length of relationship;
 - o Type of relationship
 - o Frequency of interaction between the persons involved in the relationship.
- **Stalking** engaging in a course of conduct directed at a specific person that would cause a reasonable person to:
 - o Fear for their safety or the safety of others; or
 - Suffer substantial emotional distress.
- **Robbery** defined as the taking or attempting to take anything of value from the care, custody and control of a person or persons by force or threat of force or violence, and/or putting the victim in fear.
- **Aggravated assault** defined as an unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually involves a weapon or means likely to cause death or great bodily harm.
- **Burglary** the unlawful entry into a structure to commit a felony or theft and all attempts to commit the above mentioned.
- **Arson** maliciously burning, or causing to be destroyed by burning, any public or private property.
- **Motor Vehicle Theft** defined as the theft or attempted theft of a motor vehicle.
- **Hate crimes** defined, for this report, as crimes committed against a person that manifests evidenced that the victim was intentionally selected because of the victim's actual or perceived race, gender, religion, national origin, ethnicity, disability, gender identity or sexual orientation. For this report, the hate crime must have been for one of the criminal offenses listed in the report: Larceny-theft, simple assault, intimidation, destruction / damage / vandalism of property or any other crime involving bodily injury where the victim was intentionally selected because one of the above listed biases

motivated the perpetrator.

- **Larceny-Theft** defined by the unlawful taking, carrying away, leading or riding away of property from the possession or constructive possession of another. Constructive possession is the condition in which a person does not have physical custody or possession, but is able to exercise dominion or control over a thing.
- **Simple Assault** an unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe lacerations or loss of consciousness.
- **Intimidation** to unlawfully place another person in reasonable fear of harm through the use of threatening words and/or conduct, but without displaying a weapon or subjecting the victim to physical attack.
- **Destruction / Damage / Vandalism of Property** to willfully or maliciously destroy, damage, deface or otherwise injure real or personal property without the consent of the owner or person having custody or control of it.

The Clery act requires that arrests and referrals for liquor law, drug abuse and weapons violations be reported.

- **Liquor law violations** are defined as violations of laws or ordinances prohibiting the manufacture, sale, possession, transporting or furnishing intoxicating liquors or alcoholic beverages and all attempts to commit any of the aforementioned.
- **Drug abuse violations** are defined as violations of State and local laws related to the unlawful possession, sale, use, growing or manufacturing and making of narcotic drugs.
- Weapons possession violations are defined as violations of laws or ordinances dealing
 with weapons offenses, regulatory in nature, such as: Manufacture, sale or possession of
 deadly weapons, carrying of deadly weapons, concealed or openly, furnishing deadly
 weapons to minors, aliens possessing deadly weapons and all attempts to commit any of
 the above.

There are very limited circumstances in which a report of a crime is investigated and determined to be unfounded, or believed to have occurred, by law enforcement. These types of reports are withheld from the crime statistics.

Campus Safety Services

Campus Safety provides other non-emergency services to the College community and is a source of information about the campus facilities and available services. Please feel free to call the office at any time, day or night. All members of the College community are urged to take responsibility for their own and others' security, and to report any offenses to Campus Safety personnel.





Roanoke College Annual Fire Safety Report 2024

This report is published by Roanoke College in compliance with the Higher Education Opportunity Act of 2008 and applies to student housing at the College. The Annual Fire Safety Report must include the three (3) past years of data for 2022, 2022 and 2023. The Annual Fire Safety Report Notice of Availability is distributed to all students, faculty and staff by October 1st of each year. The Annual Security Report is also distributed by October 1st of each year. These reports can be found on the Roanoke College website at https://www.roanoke.edu/inside/a-zindex/campus_safety/reports and a paper copy of the reports can be obtained at the Campus Safety Office, located at 9 North College Avenue, Salem, VA.

On Campus Housing Fire Safety Equipment

Roanoke College has twenty-five student residence halls. Fire alarm systems are networked and monitored 24/7 at the Office of Campus Safety Communications Center or by a third party, off-site central monitoring station. Campus Safety Officers and the Salem Fire Department are immediately dispatched upon the activation of an alarm. Campus Safety Officers are in communication with the local 911 dispatch center and can advise the fire department of the situation during a response. The Office of Campus Safety is to be notified of any fires that have occurred for the inclusion of the report.

Supervised Fire Drills

Fire and evacuation drills are conducted in residence halls twice in each of the Fall and Spring semesters (four times per year). The drills are supervised and conducted by the Office of Campus Safety and the Office of Residence Life. Students must participate in the fire drills and it is considered a violation of the College conduct code to not evacuate during a drill.

Evacuation Policy & Procedures

All students must evacuate a residence hall when a fire alarm sounds. The Residence Life & Housing staff (RAs) living in each hall assist in the evacuation process. Residents are instructed on the location of the assembly area for their hall by the RA staff. Residents are not permitted to re-enter the building until the "all clear" is given by the Fire Department and Campus Safety Officer on scene. Should weather conditions be inclement, or the situation prohibits a timely re-entry, evacuated students will be temporary relocated to another campus building.

Evacuation routes are posted on the back of the door of each residence hall room. Students should become familiar with multiple evacuation routes out of their building, and leave from the nearest safe exit. Students evacuating should take only important personal possessions within their immediate vicinity, as well as shoes and outer clothing suitable for the weather. Elevators are not to be used during a fire alarm evacuation of the building.

Residence Life & Housing staff and students are to assist individuals with disabilities. If someone cannot be evacuated due to an injury or disability, notify the first emergency responder you encounter as you leave the building.

All fires in residence halls must be reported to the Office of Campus Safety and the Office of Residence Life & Housing, including fires that may have been extinguished prior to the arrival of the Fire Department.

Fire Safety Violations & Prohibitions

The Student Handbook of Roanoke College contains information on residence hall policies. Each First-Year student is given a hard copy of the handbook when entering Roanoke College. The Student Handbook is also located on the college web page under Students. Residence Life & Housing staff conduct health and safety inspections of residence hall rooms on a periodic basis each semester. Listed below are fire safety guidelines and prohibitions.

- Items cannot be hung or attached to ceilings or other horizontal surfaces above the head;
- Items cannot be draped over electrical outlets, smoke detectors, lamps or other items with potential to ignite due to excessive heat exposure;
- Nothing may be placed on sprinkler pipes or within 18" of any sprinkler head;
- Electric outlets and extension cords may not be overloaded;
- All extension cords must be UL (Underwriter Laboratory) certified and should not run
 across open areas of the floor. Extension cords used for refrigerators and air conditioners
 must be of heavy-duty type with circuit breakers;
- Surge protectors should be UL approved. Instead of extension cords, use surge protectors for multiple plugs. Surge protectors should not be linked to other surge protectors, or be placed underneath carpets.
- The smoke detector battery must remain in the smoke detector. In the event the battery needs to be replaced, the student should contact a Residence Life & Housing staff member immediately.
- Burning of candles and/or incense is prohibited in residence hall rooms or common areas.
 Evidence of violations will result in disciplinary action and immediate removal of all candles.
- The use of halogen and multi-colored floor lamps is prohibited in residence hall rooms and/or common areas. Having such a lamp will result in disciplinary action and immediate removal of the lamp.
- No flammable materials or equipment may be stored in residence halls (camping stoves, lanterns, etc.).
- Live Christmas trees are not allowed in residence halls. Residence Life & Housing staff in each building will provide decoration guidelines to residents.
- Keep room clear of fire hazards that are created by the accumulation of potentially flammable materials such as newspapers, magazines, boxes, etc.
- Smoking and/or vaping is not permitted in any residence hall.

- Fireworks, flammable liquids or other hazardous materials are not permitted in residence halls.
- Tampering with fire alarms, fire protection systems or deliberately causing a false fire alarm are violations of the Student Conduct Code and students found in violation are subject to strict sanctions.

Fire Safety & Training

Residence Life & Housing professional staff and student resident advisors live in residence halls and supervise the College's residence halls. These employees receive annual fire safety, evacuation and fire extinguisher training prior to residential students arriving for the fall semester. The staff hold educational floor meetings when students arrive on campus, at which fire safety and evacuations procedures are covered with residential students. Fire evacuation routes and procedures are posted on the back of the door of each residence hall room.

Fire safety is reviewed with new employees during their orientation period. Fire safety is also addressed in the Faculty and Staff Handbooks. Specialized training is routinely provided to service employees who work in high-occupancy campus buildings and residence halls. Each department manager is responsible to see that the fire safety guidelines are followed in their respective areas.

The Office of Campus Safety and Physical Plant Office maintain an active working relationship with the City of Salem Fire Marshal and consult with that office on matters of fire safety when questions arise. The Fire Marshal's office conducts periodic inspections of campus facilities.

Plans for Future Safety Improvements

Over summer 2024, significant upgrades were made to fire control panels in buildings across the campus. As part of this upgrade to replacing aging fire alarm infrastructure, new cellular dialers were also installed on some buildings. This work will continue throughout calendar year 2025.
